- **General protective and hygienic measures:**  
The usual precautionary measures are to be adhered to when handling chemicals.
- **Respiratory protection:** Use suitable respiratory protective device only when aerosol or mist is formed.

The glove material has to be impermeable and resistant to the product/ the substance/ the preparation.
